Grand Officers, Past Grand Presidents, Officers and Members of Subordinate Parlors Native Daughters of the Golden West



It is with deep sorrow that we reflect on the life and legacy of Past Grand President Marie M. Otto, whose unwavering dedication to the Native Daughters of the Golden West spanned an incredible sixty-eight years.

Marie M. Otto was born to Ernest F. Otto and Marie S. Otto in San Diego California on November 7, 1940. Her father was born in San Diego and her mother was born in Wisselsheim, Germany. Marie grew up in San Diego, attending San Diego High School and San Diego State College graduating in 1962. She worked for a law firm for 28 years and also was a participant in the family floral business on weekends and holidays. She was called back to our Lord two days before her 84<sup>th</sup> birthday on November 5<sup>th</sup> 2024.

As a young girl Mare joined Palomar Junior Unit No. 24. In 1957 she was initiated into San Diego Parlor No. 208. During the 1987 GPAM, San Diego Parlor nominated Marie Otto for the office of Grand Outside Sentinel. During the next several years she was elected to the Board of Directors multiple times becoming Grand President on June 26, 1993 in Modesto. Her brother, George and their cousins from Germany took part in a traditional family custom mixing soil from California and Germany, representing the ancestry of the family. Her theme for the term was "Reach Out for Native Daughters". At the end of her Installation speech, Marie read a poem regarding pledging ourselves to the light of truth, freedom, faith and love binding us closer in friendship and affection. "Guided by this **light** we shall go forward to the work of another year with steadfastness and confidence." When San Diego Parlor consolidated with Grace Parlor No. 242 in January of 2021, Marie continued her membership and stayed active by learning to meet with her Parlor Sisters electronically.

Marie was not just a leader: She was a guiding light embodying the very essence of community and friendship that our organization represents. Grand President Marie Otto established the first tree lighting event at the NDGW Home on December 5<sup>th</sup> in 1993. This beloved tradition has become a symbol of unity and joy, bringing together our Members and the wider community of Native Daughters to celebrate faith, friendship and charity. This December the NDGW Home is set to hold the thirty-first annual tree lighting event. Please join together to honor Past Grand President Marie Otto through song and celebration.

As we remember Marie, let us honor her extraordinary contributions and continue her legacy of service and camaraderie within and without our vibrant community. Rest in peace dear sister and friend. Your light will continue to shine throughout our Order. Details regarding Past Grand President Marie's service will be shared as soon as possible. Donation tributes in memory of PGP Marie may be made to the NDGW Home. Thank you in advance for your generosity.



#### Hello Just Wondering,

So glad to learn that you are thinking about the future of our Order. We need Sisters like you! Here are the steps to get involved.

State Chairman: The Grand President suggests the State Chairman which are presented to the Board of Directors (Grand Officers) for final approval. You must be a Member of the Order in good standing. It helps to have served as a Committee Member for the Committee you are interested in chairing. It is also important to review the responsibilities of the Chairmanship so you understand the commitment and other expectations. If a Member is a resident of a state that borders California, and she has attended at least twothirds of her Subordinate Parlor meetings the previous year, she shall be eligible to serve on any State Committee or as a State Chairman

**Deputy Grand President** A Deputy Grand President must have served as Parlor President for two years, attending at least two-thirds of the meetings, or she may serve concurrently as Past President of a Subordinate Parlor during her appointment as Deputy Grand President. Subordinate Parlor. Members aspiring to a Grand Parlor office shall have previously served at least one year as a Deputy Grand President to a Subordinate Parlor. **Remember**, the Grand Vice President is currently taking suggestions for the State Chairman and Deputy Grand Officer positions. If you are interested in becoming a Grand Officer, please speak to a current Grand Officer or Past **Grand Preside**


### Let's Help California Teens Meet their Future! Submitted By: Sandra Firpo Public Relations and Community Outreach Committee (PRACO)

#### What Happens with my NDGW Dues??!! Submitted By: Darleen Carpenter, Grand President & Past Finance Chair (Re-printed by popular demand!)

As you know, we all pay dues to our Subordinate Parlors and a portion of our dues are then paid to Grand Parlor via (per capita assessments –sometimes called *"Per-capita tax"*). You might ask, *"What do I* get for this?" Well, let me explain.

Every non-profit incurs administrative costs to assist with managing the organization and to provide services for its members. Our Native Daughters of the Golden West organization is no different.

The bulk of our income is generated from dues (per capita), interest from our investments, and a small amount of administrative fees from our state Committees for service rendered to those Committees.

We are fortunate that we own our NDGW building so there is no rent to be paid, but we do have property taxes to pay along with utilities to light and heat the building. We also need staff to answer the phones, send monthly mailings, provide supplies to Parlors as requested, maintain our membership records, and maintain the Grand Parlor Office. We also have a bookkeeper who makes deposits, issues check, processes payroll and payroll taxes, provides monthly reports to our Committees, bills Parlors for Per capita and insurance, records and manages the books of the Order and coordinates our Annual Tax returns (required by law) with the CPA. There are also costs for phone, office supplies, postage, cleaning, CPA fees, insurance, legal, California Star.

Additionally, there are also costs for the GPAM as mandated by our Books of the Order for our annual meeting which is required by law to maintain our non-profit status.



So, as you can see, the dues you pay are vital to operating our organization and servicing the needs of our members, maintaining our non-profit status, and preserving California history and continuing our programs and projects.

Thank you to all of our Sisters for being Members of the Native Daughters of the Golden West; your membership (donations, and volunteerism!) truly helps A LOT!!
